**AMENDING SECTION 1 AND SECTION 4 OF EXECUTIVE ORDER NO. 31,
SERIES OF 2023, ENTITLED “RECONSTITUTION OF THE INSTITUTIONAL
STRENGTHENING COMMITTEE (ISC) OF THE PROVINCIAL GOVERNMENT
OF DAVAO ORIENTAL”**

Attendance of Technical Advisors to the ISC regular or special meeting shall depend on the agenda matters that will be taken up, for which the ISC Secretariat shall send due notice inviting his/her/their presence thereto.

Executive Order No. 31, Series of 2023, is hereby modified. All orders and issuances, or parts thereof which are inconsistent with this Order are hereby repealed or modified accordingly. This Executive Order takes effect immediately upon its approval.
