A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO AND EXECUTE THE HEREIN MEMORANDUM OF AGREEMENT (MOA) AND DEED OF DONATION AND ACCEPTANCE (DODA) WITH THE MUNICIPAL GOVERNMENT OF SAN ISIDRO, THIS PROVINCE, REPRESENTED BY ITS MUNICIPAL MAYOR, HONORABLE ANGELICA T. GO, RELATIVE TO THE ONGOING IMPLEMENTATION OF THE PROVINCE-WIDE INSTALLATION OF THE ENHANCED TAX REVENUE ASSESSMENT AND COLLECTION SYSTEM (ETRACS).

WHEREAS, the province-wide installation of the Enhanced Tax Revenue Assessment and Collection System (ETRACS) is intended to automate the real property

tax administration and local revenue collection, developed and maintained by RAMESES SYSTEMS INC., hence, the province will be able to adopt and implement a uniform IS that allows interoperability linkage between the PLGU and its component MLGUs, which will significantly improves the treasury and assessment operations;

WHEREAS, the Provincial Government of Davao Oriental and the Local Government Unit (LGU) of San Isidro shall perform their responsibilities in accordance with the provisions of this MOA and undertake all means necessary to realize, promote, and sustain the implementation of ETRACS in the Province;

WHEREAS, the PLGU of Davao Oriental shall procure and turn over (donate) to LGU San Isidro all hardware, equipment, computers, devices, cables, and other materials to be use in the implementation of ETRACS in the MLGU's Treasurer's Office and Assessor's Office;

WHEREAS, Chapter 3, Section 465(b)(1)(vi) of the Local Government Code of 1991, states that: "the Provincial Governor, as the Chief Executive of the Provincial Government, shall *represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance*";

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly second by SP Members Shella Marie S. Go, Stephen Paul L. Uy, and Jossone Michael G. Dayanghirang, it was
