UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO SIGN A DEED OF DONATION/ACCEPTANCE WITH THE UNITED NATIONS CHILDREN’S FUND (UNICEF), REPRESENTED BY UNICEF PHILIPPINES REPRESENTATIVE, MISS OYUNSAIKHAN DENDEVNOROV, RELATIVE TO THE DONATION OF VARIOUS COLD CHAIN EQUIPMENT INCLUDING WALK-IN COLD ROOM AND DEVICES FOR VACCINE STORAGE UNDER THE NATIONAL IMMUNIZATION PROGRAMME (NIP) AND COVID-19.

WHEREAS, the UNICEF acquired grant from the Asian Development Bank (ADB) for the procurement of various cold chain equipment including walk-in cold room and devices and the provincial government accepts full ownership of the following, in particular:
