A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 06-08-07-2024 OF THE SANGGUNIANG BAYAN OF CATEEL, DAVAO ORIENTAL, ENTITLED: "ENACTING THE REVISED GENDER AND DEVELOPMENT (GAD) CODE OF THE MUNICIPALITY OF CATEEL, PROVINCE OF DAVAO ORIENTAL", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.
