A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 06-08-07-2024 OF THE SANGGUNIANG BAYAN OF CATEEL, DAVAO ORIENTAL, ENTITLED: “ENACTING THE REVISED GENDER AND DEVELOPMENT (GAD) CODE OF THE MUNICIPALITY OF CATEEL, PROVINCE OF DAVAO ORIENTAL”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, in her letter, dated July 31, 2024, Miss Romilda A. Marquez, Secretary to the Sangguniang Bayan of Cateel, this Province, submitted the abovementioned Municipal Ordinance for legislative review of the Sangguniang Panlalawigan, docketed as Communication No. 17-1020-2024;

WHEREAS, the said ordinance is the enactment of the Revised GAD Code of the Municipality of Cateel institutionalizing gender-responsive governance in the said municipality by ensuring that gender perspectives are incorporated in all its programs, projects and activities;

WHEREAS, the subject Municipal Ordinance was passed and approved by the Sangguniang Bayan on July 8, 2024, signed and approved by the Municipal Mayor Emilou C. Nuñez, on July 31, 2024;


