TERESITA G. INCIONG, RELATIVE TO THE IMPLEMENTATION OF THE RECOGNITION/ACCREDITATION OF CHILD DEVELOPMENT CENTERS (CDCs) AND CHILD DEVELOPMENT WORKERS (CDWs).

WHEREAS, the facilitation and coordination functions of the DSWD-Field Offices will now be with the Provincial Government through the Provincial Social Welfare and Development Office/Provincial ECSD Office;

WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states among others that: *“the Provincial Governor, as the Chief Executive of the Provincial Government, shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance”*;


