A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 01, SERIES OF 2024, OF THE MUNICIPALITY OF GOVERNOR GENEROSO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 01, series of 2024, of the Municipality of Governor Generoso, Davao Oriental, authorizing its CY 2024 General Fund Supplemental Budget No. 01, involving an appropriation of SEVEN MILLION NINE HUNDRED ONE THOUSAND ONE HUNDRED THIRTY-SEVEN PESOS & 53/100 (P7,901,137.53), was submitted to this Sanggunian for review on June 21, 2024, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Harold A. Montes, Jossone Michael G. Dayanghirang, Andy A. Monday, Anna Cheryl N. Castro, and Shanine C. Lintogonan, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 01, series of 2024, of the Municipality of Governor Generoso, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. Lump sum appropriations for Locally Funded appropriations/MOOE/Capital Outlay, etc. shall be subject to Sections 305(b) and 335 of RA 7160; RA 9185 (Government Procurement Reform Act) and its Revised IRR, and other existing pertinent laws, rules and regulations imposing restraints on government expenditures;
2. The fund appropriation for PPAs funded in this budget shall be in accordance with the approved CY 2024 Annual Investment Program (AIP) and/or Supplemental Annual Investment Program (SAIP), pursuant to Sections 287 and 305(i) of RA 7160; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, s. 2016, dated November 18, 2016.

MOREOVER, the LGU is reminded of Section 56 in relation with Sections 326 and 327 of the Local Government Code which provides that within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review.

RESOLVED FURTHER, to inform the Municipality of Governor Generoso, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Governor Generoso, Davao Oriental, through the Municipal Mayor.






