A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 03-17-2024 OF THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 03-17-2024 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2024 General Fund Supplemental Budget No. 03, involving an appropriation of **NINE MILLION THREE HUNDRED SIXTY-ONE** THOUSAND TWO HUNDRED FORTY-EIGHT PESOS & 26/100 (P9,361,248.26), was submitted to this Sanggunian for review on June 21, 2024, pursuant to the provisions of Republic Act No. 7160;

**RESOLVED,** to declare Appropriation Ordinance No. 03-17-2024 of the Municipality of San Isidro, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160.

MOREOVER, the LGU is reminded of Section 56 in relation with Sections 326 and 327 of the Local Government Code which provides that within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review.

**RESOLVED FURTHER,** to inform the Municipality of San Isidro, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of San Isidro, Davao Oriental, through the Municipal Mayor.
