A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2024-06 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE LOCALIZING THE IMPLEMENTATION AND APPLICATION OF REPUBLIC ACT NO. 7277 AS AMENDED BY REPUBLIC ACT NO. 9442 OTHERWISE KNOWN AS "MAGNA CARTA FOR PERSONS WITH DISABILITY AND PROVIDING FUNDS THEREOF, AND FOR OTHER PURPOSES".
