WHEREAS, presented for consideration before the August Body is an urgent request from the Honorable Governor Niño Sotero L. Uy, Jr., thru his letter, dated August 27, 2024, requesting for the passage of a resolution authorizing him for the aforementioned subject matter, docketed as Communication No. 17-1044-2024;

WHEREAS, Republic Act 10869 or the *JobStart Act* was enacted to institutionalize the nationwide implementation of JobStart Philippines program and provide the essential administrative and management requirements to implement the same and used as guide to DOLE and Public Employment Service Offices (PESOs) in the implementation of the said program;

WHEREAS, Public Employment Service Offices (PESOs) maintained largely by the Local Government Units (LGUs) shall be linked to the Regional Offices of the DOLE for coordination and technical supervision, and to the DOLE central office, to constitute the national employment service networks as stated among others, under the PESO Act of 1999;


