A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO SIGN A DEED OF DONATION WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG), REPRESENTED BY ITS PROVINCIAL DIRECTOR, MR. ORLE A. CABAUBAO, RELATIVE TO THE DONATION OF AN ADDITIONAL LOT CONTAINING AN AREA OF FOUR HUNDRED (400) SQUARE METERS, LOCATED AT THE GOVERNMENT CENTER, BARANGAY DAHICAN, CITY OF MATI, THIS PROVINCE, FOR THE SITE OF ITS ADDITIONAL BUILDING INTENDED FOR TRAININGS AND OTHER PURPOSES.

WHEREAS, the 15th Sangguniang Panlalawigan already passed a legislative measure thru Resolution No. 15-651-03-2019 authorizing the former Provincial Governor, Honorable Nelson L. Dayanghirang, Sr., relative to the aforementioned subject matter. However, due to change of administration, there is a need to pass another resolution to authorize the present Provincial Governor, Honorable Niño Sotero L. Uy, Jr.;
