WHEREAS, in his letter, dated August 15, 2024, Mr. Val E. Amigo, Secretary to the Sangguniang Bayan of Governor Generoso, this Province, submitted the abovementioned Ordinance for legislative review of the Sangguniang Panlalawigan;
