A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 10, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE PROVIDING MEASURES ON DENGUE PREVENTION AND PENALIZING VIOLATORS THEREOF AND TO INSTILL HEALTH CONSCIOUSNESS", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.
