A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 09, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE BANNING MINORS FROM BUYING AND USING LIQUORS AND CIGARETTES AND PROHIBITING STORE/EATERY/BAR OWNER OPERATORS FROM SELLING SAID ITEMS TO THESE YOUNGSTERS”, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, in his letter, dated August 15, 2024, Mr. Val E. Amigo, Secretary to the Sangguniang Bayan of Governor Generoso, this Province, submitted the abovementioned Ordinance for legislative review of the Sangguniang Panlalawigan;

WHEREAS, this ordinance prohibits minors seventeen (17) years of age and below, of either sex, from buying liquors or cigarettes and/or from taking and using the same, and likewise prohibits owners/operators of stores, eateries, restaurants, and

bars from selling cigarettes or liquors to minors, even if they are accompanied by an adult;


