WHEREAS, Section 12 of Republic Act 9003, otherwise known as the “*Ecological Solid Waste Management Act of 2000*”, mandates the Cities and Municipalities for the creation of Waste Management Board, furthermore providing its composition, duties and responsibilities;

WHEREAS, Section 468(a)(1)(i) of RA. 7160, provides the power of the Sangguniang Panlalawigan to review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor;




