A RESOLUTION CONFIRMING THE VALIDITY OF EXECUTIVE ORDER NOS. 92 AND 93, BOTH SERIES OF 2024, ISSUED BY THE HONORABLE CITY MAYOR MICHELLE N. RABAT OF MATI, DAVAO ORIENTAL, CONSIDERING THAT THE SAME ARE WITHIN THE PRESCRIBED POWERS OF THE CITY MAYOR, PURSUANT TO ARTICLE 1, SECTION 455(b)(2)(iii) OF REPUBLIC ACT NO. 7160.

WHEREAS, Honorable City Mayor Michelle N. Rabat, issued the aforementioned executive orders on August 27, 2024, for the creation of Local Inter - Agency Committee (LIAC) in different Housing Projects in the City of Mati which shall act as the policy and decision making, coordinating, and consultative body; and supervising and monitoring of sub-committee that shall cause and implement programs, projects, and plans related to such activities;

WHEREAS, Section 39 of Republic Act 7292, otherwise known as "Urban Development and Housing Act of 1992", recognizes the role of Local Government Units (LGUs) being charged with the implementation of this Act in their respective localities, in

coordination with the Housing and Urban Development Coordinating Council, the national housing agencies, the Presidential Commission for the Urban Poor, the private sector and other nongovernment organizations;

WHEREAS, Section 468(a)(1)(i) of RA. 7160, provides the power of the Sangguniang Panlalawigan to review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor;

WHEREFORE, on motion of SP Member Harold A. Montes, duly and jointly seconded by SP Members Rotchie M. Ravelo, Anna Cheryl N. Castro, Andy A. Monday, Art Benjie C. Bulaong, Shanine C. Lintogonan, Joselito B. Villademoso, and Marietta D. Palmera, it was






