**A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 02, SERIES OF 2024, OF THE CITY OF MATI, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 02, series of 2024, of the City of Mati, Davao Oriental, authorizing its CY 2024 General Fund Supplemental Budget No. 02, involving an appropriation of **TWENTY-ONE MILLION FOUR HUNDRED EIGHTY-TWO THOUSAND TWO HUNDRED EIGHTY-ONE PESOS & 03/100 (P21,482,281.03)**, was submitted to this Sanggunian for review on July 8, 2024, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 02, series of 2024, of the City of Mati, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. Positions in the official plantilla for career position if occupied by incumbents holding permanent appointments must be covered with adequate appropriations (Section 325(e) of RA 7160).
2. Lump sum appropriations in Special Purpose Appropriations/Other MOOE/Capital Outlay, etc. shall be subject to Sections 305(b) and 335 of RA 9184 (Government Procurement Reform Act) and its Revised IRR, and other existing pertinent laws, rules and regulations imposing restraints on government expenditures.

**RESOLVED FURTHER**, to inform the City of Mati, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Panlungsod of Mati, Davao Oriental, through the City Mayor.


