A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 617, SERIES OF 2024, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWER OF THE SANGGUNIANG PANLUNGSOD, SUBJECT TO SECTION 123 OF RA 7653, AS IMPLEMENTED BY THE BANGKO SENTRAL NG PILIPINAS CIRCULAR NO. 402, AND OTHER LAWS AND REGULATIONS PERTINENT THERETO.

WHEREAS, submitted for review before this August Body is City Ordinance No. 617, series of 2024, entitled: "AN ORDINANCE RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN WITH THE LAND BANK OF THE PHILIPPINES IN THE AMOUNT OF THREE HUNDRED SIXTY-SIX MILLION FIVE HUNDRED THOUSAND PESOS (P 366,500,000.00) TO FINANCE THE FOLLOWING PROJECTS OF THE CITY GOVERNMENT OF MATI: (1) TERM LOAN 36 - WASTE WATER TREATMENT FACILITY (P17,000,000.00); (2) TERM LOAN 37 - ACQUISITION AND INSTALLATION OF SOLAR PANELS (P76,500,000.00); (3) TERM

LOAN 38 – POTABLE WATER SYSTEM (P20,000,000.00); (4) CONSTRUCTION AND IMPROVEMENT OF PUBLIC FACILITIES (P158,000,000.00); (5) TERM LOAN 40 - ACQUISITION AND INSTALLATION OF LED WALL (P7,000,000.00); (6) ACQUISITION OF HEAVY EQUIPMENT AND LIGHT VEHICLES (P86,000,000.00); (7) ACQUISITION SURVEY EQUIPMENT (P2,000,000.00); GRANTING THE LOCAL CHIEF EXECUTIVE, HON. MICHELLE MARIE DENISE N. RABAT, THE FULL POWER AND AUTHORITY TO REPRESENT THE CITY GOVERNMENT OF MATI, PROVINCE OF DAVAO ORIENTAL TO SIGN AND EXECUTE DOCUMENTS RELATED TO THE BORROWING; AND APPROVING THE TERMS AND CONDITIONS SET FORTH BY THE LENDING INSTITUTION”, docketed as Communication No. 17-1077-2024;

WHEREAS, said City Ordinance was enacted by the Sangguniang Panlungsod on September 24, 2024, and the same was approved by the City Mayor;

WHEREAS, Section 296(a) and Article 394(a) of RA 7160 and its IRR, respectively, states that the LGU may create indebtedness and avail of credit facilities to finance local infrastructure and other socio-economic development projects in accordance with the approved local development plan and public investment program;




