A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NOS. 2024-11 AND 2024-12 OF THE SANGGUNIANG BAYAN OF LUPON, DAVAO ORIENTAL, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, Municipal Ordinance No. 2024-11, entitled: "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2018-06, ENTITLED: "AN ORDINANCE ADOPTING A MECHANISM THAT INSTITUTIONALIZES PUBLIC HEALTH SERVICES OF BARANGAY HEALTH WORKERS (BHW) AND BARANGAY NUTRITION SCHOLARS (BNS) IN THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL AND PROVIDING FUNDS THEREFOR", otherwise known as the "BHW/BNS Welfare Ordinance";

WHEREAS, Municipal Ordinance No. 2024-12, entitled: *“AN ORDINANCE ADOPTING THE IMPLEMENTATION OF THE PHILIPPINE APPROACH TO SUSTAINABLE SANITATION (PhATSS) IN LUPON, DAVAO ORIENTAL, PROVIDING POLICIES, GUIDELINES, MECHANISMS AND APPROPRIATION THEREOF”*, otherwise known as the *“Municipal-wide Approach to Sustainable Sanitation (MATSS) Ordinance of Lupon, Davao Oriental”*;

WHEREAS, in her letter, dated October 10, 2024, Ms. Fatima L. Malaluan, Secretary to the Sangguniang Bayan of Lupon, Davao Oriental, submitted the aforementioned ordinances for legislative review and appropriate action of the Sangguniang Panlalawigan;




