A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE XI (DA RFO XI), REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, MR. MACARIO D. GONZAGA, RELATIVE TO THE REHABILITATION AND RECOVERY PROGRAM FOR SHEARLINE AND LOW-PRESSURE AREA (LPA) AFFECTED FARMERS ON RESTOCKING OF ANIMALS FOR THE FARMERS OF THIS PROVINCE.

WHEREAS, the Department of Agriculture Central Office acknowledges that provinces in Region XI suffered heavy damages brought by the combined effects of Shearline and Low-Pressure Area LPA which brought by lodging and flooding on crop as well as casualties in livestock, poultry and fisheries;

WHEREAS, the Department of Agriculture Region XI proposed a Rehabilitation and Recovery Plan to farm areas and animals and fish farmers affected by the combined effects of Shearline and Low-Pressure Area LPA, and has allotted **Three Million Five Hundred Thirty-Five Thousand Pesos (Php3,535,000.00)** to this Province;

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Anna Cheryl N. Castro and Daud V. Linsag, it was
