A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 100, SERIES OF 2024, OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 100, series of 2024, of the Municipality of Boston, Davao Oriental, authorizing its CY 2024 General Fund Supplemental Budget No. 2, involving an appropriation of **EIGHT MILLION FOUR HUNDRED FORTY-SIX THOUSAND TWO HUNDRED SIXTY-NINE PESOS AND 24/100 (P8,446,269.24)**, was submitted to this Sanggunian for review on August 27, 2024, pursuant to the provisions of Republic Act No. 7160;

FURTHERMORE, the LGU is herein reminded of Section 56 in relation with Sections 326 and 327 of the Local Government Code which provides that within three (3) days after approval of the Ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Boston, Davao Oriental, through the Municipal Mayor.


