**A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 03, SERIES OF 2024, OF THE CITY OF MATI, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 03, series of 2024, of the City of Mati, Davao Oriental, authorizing its CY 2024 General Fund Supplemental Budget No. 03, involving an appropriation of **THIRTY MILLION THIRTY-FOUR THOUSAND SEVEN HUNDRED FORTY-TWO PESOS & 40/100 (P30,034,742.40)**, was submitted to this Sanggunian for review on August 29, 2024, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its implementing Rules and Regulations;

**RESOLVED**, to declare Appropriation Ordinance No. 03, series of 2024, of the City of Mati, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. Utilization of funds for the PPAs under the 5% Calamity Fund shall be in accordance with NDRRMC-DBM-DILG Joint Circular No. 2013-1, dated March 25, 2013.
2. Utilization of funds for PPAs under the 20% Development Fund shall be in accordance with DBM-DOF-DILG Joint Memorandum Circular No. 1, s. 2020, dated November 4, 2020; and DBM-DOF-DILG Joint Memorandum Circular No. 1, dated April 27, 2023.

**RESOLVED FURTHER**, to inform the City of Mati, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Panlungsod of Mati, Davao Oriental, through the City Mayor.
