A RESOLUTION UPDATING THE CULTURAL PROPERTY INVENTORY OF THE PROVINCE OF DAVAO ORIENTAL, ADOPTING THE OFFICIAL LIST OF LOCAL CULTURAL INVENTORY AND ENDORSING TO THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) FOR INCLUSION IN THE PHILIPPINE REGISTRY OF CULTURAL PROPERTY (PRECUP).

WHEREAS, presented for consideration before the August Body is a letter from the Honorable Governor Niño Sotero L. Uy, Jr., dated November 5, 2024, requesting for the passage of the aforementioned subject matter, docketed as Communication No. 17-114-2024;

WHEREAS, Republic Act No. 10066, otherwise known as the **“National Cultural Heritage Act of 2009”**, provides among others for the protection, preservation, conservation and promotion of the historical and cultural heritage of our nation;

WHEREAS, Section 14(b) of the same Act, mandates the Local Government Units, through their cultural offices, to maintain an inventory of cultural property under its jurisdiction and shall furnish the Commission a copy of the same;

WHEREAS, Republic Act 7160 or the Local Government Code of 1991, further provides that the Local Government Units shall ensure and support, among other things, the preservation and enrichment of culture;

WHEREAS, the Department of the Interior and Local Government (DILG) and the National Commission for Culture and the Arts (NCCA) issued Joint Memorandum Circular No. 2021-001, dated May 07, 2021, which mandates the Local Government Units to submit its Local Cultural Inventory (LCI) to the National Commission for Culture and the Arts (NCCA) for inclusion in the Philippine Registry of Cultural Property (PRECUP) which is deemed important to its cultural heritage, pursuant to Republic Act No. 10066, otherwise known as the "**National Cultural Heritage Act of 2009**";

WHEREAS, the province of Davao Oriental possesses a rich tapestry of culture heritage and historical sites that reflect its unique identity and contribute significantly to its tourism potential;

WHEREAS, it is imperative to maintain a comprehensive and updated inventory of these cultural properties to ensure their proper preservation, protection, and promotion;




WHEREAS, the Cultural Properties in the Province of Davao Oriental are hereby updated in the Provincial Inventory as follows:




