A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 08, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF TARRAGONA, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE STRENGTHENING PUROK ORGANIZATION IN THE MUNICIPALITY OF TARRAGONA, DAVAO ORIENTAL AS PARTNER IN INSTITUTIONALIZING GOOD GOVERNANCE AT THE GRASSROOTS LEVEL, PROVIDING SUPPORT MECHANISMS AND PRESCRIBING PENALTIES IN VIOLATION THEREOF", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF R.A. 7160.

WHEREAS, in her letter, dated November 13, 2024, Ms. Irene D. Tinong, Secretary to the Sangguniang Bayan of Tarragona, this Province, submitted the abovementioned Ordinance for legislative review of the Sangguniang Panlalawigan, docketed as Communication No. 17-1116-2024;

WHEREAS, the said Municipal Ordinance otherwise known as "*PUROK ORGANIZATION FOR GOOD GOVERNANCE ORDINANCE OF 2024*" was enacted by the Sangguniang Bayan of the abovementioned municipality on August 5, 2024, and the same was signed and approved by the Municipal Mayor on November 13, 2024;




