OSMAN, RELATIVE TO THE UTILIZATION OF BALAY SILANGAN REFORMATION CENTER IN SITIO MAGAY, DON MARTIN MARUNDAN, CITY OF MATI, THIS PROVINCE, FOR THE SAID LGU's DRUG DEPENDENT PATIENTS REHABILITATION AND TREATMENT, PURSUANT TO REPUBLIC ACT NO. 11223, OTHERWISE KNOWN AS "UNIVERSAL HEALTH CARE ACT".

WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states that the Provincial Governor, as the chief executive of the provincial government, shall "represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance";
