**A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 14, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, PURSUANT TO SECTION 296(a) AND ARTICLE 394(a) OF RA 7160 AND ITS IRR, RESPECTIVELY, SUBJECT TO SECTION 123 OF RA 7653, AS IMPLEMENTED BY THE BANGKO SENTRAL NG PILIPINAS CIRCULAR NO. 402, AND OTHER LAWS AND REGULATIONS PERTINENT THERETO.**

**WHEREAS**, submitted for review before this August Body is Municipal Ordinance No. 14, series of 2024, entitled: *“AN ORDINANCE RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN WITH THE LAND BANK OF THE PHILIPPINES IN THE AMOUNT OF TWO HUNDRED TWO MILLION PESOS (P 202,000,000.00) ONLY TO FINANCE: (1) LAND ACQUISITION; (2) ESTABLISHMENT OF SANITARY LANDFILL; (3) IMPROVEMENT OF TOURISM COMPLEX;*

(4) IMPROVEMENT OF SLAUGHTERHOUSE; (5) CONSTRUCTION OF OFFICE BUILDING; (6) CONSTRUCTION OF ABC BUILDING; (7) COMPUTERIZATION AND MODERNIZATION PROJECT; (8) ACQUISITION OF HEAVY EQUIPMENT AND ALL-PURPOSE VEHICLES; (9) LAND DEVELOPMENT PROJECTS; GRANTING THE LOCAL CHIEF EXECUTIVE, HON. JUANITO C. INOJALES, THE FULL POWER AND AUTHORITY TO REPRESENT THE MUNICIPALITY OF GOVERNOR GENEROSO, DAVAO ORIENTAL PROVINCE, TO SIGN AND EXECUTE DOCUMENTS RELATED TO THE BORROWING INCLUDING THE ASSIGNMENT OF 20% OF NATIONAL TAX ALLOTMENT AS SECURITY TO THE LOAN; AND APPROVING THE TERMS AND CONDITIONS SET FORTH BY THE LENDING INSTITUTION”, docketed as Communication No. 17-1129-2024;

**WHEREAS**, said Municipal Ordinance was enacted by the Sangguniang Bayan on November 26, 2024, and the same was signed and approved by the Honorable Mayor on the same date;

**WHEREAS**, Section 296(a) and Article 394(a) of RA 7160 and its IRR, respectively, states that the “LGU may create indebtedness and avail of credit facilities to finance local infrastructure and other socio-economic development projects in accordance with the approved local development plan and public investment program”;

**WHEREFORE**, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Harold A. Montes, Shanine C. Lintogonan, and Art Benjie C. Bulaong, it was
