**A RESOLUTION CONFIRMING THE VALIDITY OF THE MUNICIPAL ORDINANCE NO. 2024-10 OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE AMENDING, REVISING, AND CODIFYING THE MUNICIPAL ORDINANCE NO. 2018-05, OTHERWISE KNOWN AS THE LOCAL REVENUE CODE OF LUPON, PROVINCE OF DAVAO ORIENTAL”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO SECTION 132 OF RA 7160.**

**WHEREAS**, Sangguniang Bayan Secretary Fatima L. Malaluan has forwarded the aforementioned Municipal Ordinance relative to the local revenue measure of the Municipality of Lupon, for review and appropriate action of this Sangguniang Panlalawigan;

**WHEREAS**, the Sangguniang Bayan, pursuant to Section 187 of RA 7160, has conducted a public hearing on September 9, 2024, before the enactment of the subject Municipal Ordinance on September 30, 2024;

**WHEREAS**, Section 132 of the Local Government Code of 1991 provides for the power of the LGU concerned to impose a tax, fee or charge to generate revenue through an appropriate ordinance;

**WHEREAS**, upon review of the Office of the Provincial Treasurer, the same is found to be consistent with the constitution and national laws, scope of taxing and regulatory powers (Section 133, LGC), rate/frequency of increase (Section 191, LGC), compliance with the mandatory procedures on the enactment of Local Revenue Code (Section 187, LGC), and in accordance with DILG-DOF Joint Memorandum Circular No. 2019-01. Therefore, the said Municipal Ordinance is valid and implementable;

**WHEREFORE**, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Eleuterio C. Manaytay, Shella Marie S. Go, Harold A. Montes, Marietta D. Palmera, Art Benjie C. Bulaong, and Michelle M. Centeno, it was




