A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 10, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF CARAGA, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE CREATING THE PLANTILLA POSITION OF LOCAL LEGISLATIVE STAFF OFFICER IV WITH SALARY GRADE 19 UNDER THE OFFICE OF THE SECRETARY TO THE SANGGUNIAN OF THE MUNICIPAL GOVERNMENT OF CARAGA, DAVAO ORIENTAL, DEFINING ITS DUTIES AND FUNCTIONS, AND APPROPRIATING FUNDS THEREFOR", CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, Section 76 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that: "Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission";
