A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 10, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF CARAGA, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE CREATING THE PLANTILLA POSITION OF LOCAL LEGISLATIVE STAFF OFFICER IV WITH SALARY GRADE 19 UNDER THE OFFICE OF THE SECRETARY TO THE SANGGUNIAN OF THE MUNICIPAL GOVERNMENT OF CARAGA, DAVAO ORIENTAL, DEFINING ITS DUTIES AND FUNCTIONS, AND APPROPRIATING FUNDS THEREFOR”, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH LAW.

WHEREAS, pursuant further to Section 468(a)(1)(i) of the same Code, the aforementioned Municipal Ordinance is within the prescribed powers of the Sangguniang Bayan in relation to Section 76;
