2. Utilization of funds for PPAs under the 20% Development Fund shall be in accordance with DBM-DOF-DILG Joint Memorandum Circular No. 1, s. 2020, dated November 4, 2020.

RESOLVED FURTHER, to inform the Municipality of Baganga, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Baganga, Davao Oriental, through the Municipal Mayor.


