A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 12, SERIES OF 2024, OF THE MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 12, series of 2024, of the Municipality of Baganga, Davao Oriental, authorizing its CY 2024 General Fund Supplemental Budget No. 01, involving an appropriation of SIXTY-THREE MILLION SEVEN HUNDRED SIXTY-SIX THOUSAND SEVEN HUNDRED EIGHTY PESOS & 61/100 (P63,766,780.61, was submitted to this Sanggunian for review on August 19, 2024, pursuant to the provisions of Republic Act No. 7160;

- Fund appropriation for PPAs funded in this budget shall be in accordance with the approved CY 2024 Annual Investment Program (AIP) and/or Supplemental Annual Investment Program (SAIP)/Development Plan, pursuant to Sections 287 and 305(i) of RA 7160; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, s. 2016, dated November 18, 2016.
- Utilization of funds for PPAs under the 20% Development Fund shall be in accordance with DBM-DOF-DILG Joint Memorandum Circular No. 1, s. 2020, dated November 4, 2020.

**RESOLVED FURTHER**, to inform the Municipality of Baganga, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Baganga, Davao Oriental, through the Municipal Mayor.
