A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 13, SERIES OF 2024, OF THE MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 13, series of 2024, of the Municipality of Baganga, Davao Oriental, authorizing its CY 2024 General Fund Supplemental Budget No. 02, involving an appropriation of **THIRTEEN MILLION SIX HUNDRED EIGHTY-THREE THOUSAND FOUR HUNDRED EIGHTEEN PESOS & 09/100 (P13,683,418.09)**, was submitted to this Sanggunian for review on October 22, 2024, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 13, series of 2024, of the Municipality of Baganga, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. Fund appropriation for PPAs funded in this budget shall be in accordance with the approved CY 2024 Annual Investment Program (AIP) and/or Supplemental Annual Investment Program (SAIP)/Development Plan, pursuant to Sections 287 and 305(i) of RA 7160; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2016, dated November 18, 2016.
2. The implementation of Salary Increase shall be in accordance with LBC No. 160, dated August 12, 2024.

RESOLVED FURTHER, to inform the Municipality of Baganga, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Baganga, Davao Oriental, through the Municipal Mayor.


