**A RESOLUTION DERECOGNIZING THE UNSERVICEABLE MACHINERIES AND EQUIPMENT OWNED BY THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, CURRENTLY UNDER THE CUSTODY OF THE PROVINCIAL AGRICULTURE OFFICE (PAGRO), THEREBY APPROVING ITS TRANSFER WITHOUT COST TO SELECTED BARANGAYS FROM DISTRICT I AND II FOR THE BENEFIT OF FARMERS AND FISHERFOLKS OF THIS PROVINCE.**

**WHEREAS**, the Acting Provincial Agriculturist, Dr. Edito B. Sumile, in his letter, dated September 30, 2024, submitted to the Honorable Governor the list of equipment and machineries owned by the Provincial Government of Davao Oriental that are considered unserviceable;

**WHEREAS**, based on the inventory appraisal report, the following are being requested to be transferred without cost to selected barangays from District I and II, viz:

**WHEREAS**, Section 381 of the Local Government Code of 1991, provides that: *“Property which has become unserviceable or is no longer needed may be transferred without cost to another office, agency, subdivision or instrumentality of the national government or another local government unit at an appraised valuation determined by the local Committee on Awards. Such transfer shall be subject to the approval of the sanggunian concerned making the transfer and by the head of the office, agency, subdivision, instrumentality or local government unit receiving the property”;*




