A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 2024-20-04 OF THE SANGGUNIANG BAYAN OF MANAY, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE ESTABLISHING CEMETERY CODE OF 2024 IN THE MUNICIPALITY OF MANAY, PROVINCE OF DAVAO ORIENTAL AND PROVIDING FUNDS FOR OPERATION THEREFORE". CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF R.A. 7160.

WHEREAS, in his letter, dated October 3, 2024, Mr. Arlando T. Fernandez, Records Officer II/OIC-Secretary to the Sangguniang Bayan of Manay, this Province, submitted the aforementioned ordinance for reference and appropriate action of this Sangguniang Panlalawigan; Ruplaza

**WHEREAS**, the subject Municipal Ordinance was enacted by the 20<sup>th</sup> Sangguniang Bayan of the above-mentioned municipality on its 108<sup>th</sup> Regular Session held on September 3, 2024, and was approved by the Honorable Mayor on September 27, 2024;

WHEREAS, the Manay Cemetery Code, declares that: "the State shall guarantee and promote the autonomy of local government units to ensure their fullest development as self-reliant communities and make them more effective partners in the pursuit of national development and social progress". This is in furtherance to the constitutional mandate which provide that "each local government unit shall have the power to create its own sources of revenue and to levy taxes" to ensure their viability and self-sufficiency;
