WHEREAS, the subject Municipal Ordinance was enacted by the 20th Sangguniang Bayan of the above-mentioned municipality on its 108th Regular Session held on September 3, 2024, and was approved by the Honorable Mayor on September 27, 2024;

WHEREAS, the Manay Cemetery Code, declares that: *“the State shall guarantee and promote the autonomy of local government units to ensure their fullest development as self-reliant communities and make them more effective partners in the pursuit of national development and social progress”*. This is in furtherance to the constitutional mandate which provide that *“each local government unit shall have the power to create its own sources of revenue and to levy taxes”* to ensure their viability and self-sufficiency;




