WHEREAS, it is stipulated in the MOA that the DY Green Energy Corporation shall have the exclusive property use for fifteen (15) years of the 40 hectare-property situated in Brgy. Maputi, Municipality of Banaybanay, owned by the PLGU, which is to be leased to the Corporation in the amount of P500,000.00 per month, subject to the terms and conditions of a lease agreement;




