A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NOS. 15-11-12-2024 AND 15-12-12-2024 OF THE SANGGUNIANG BAYAN OF BOSTON, DAVAO ORIENTAL, CONSIDERING THAT THE SAME ARE WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, Municipal Ordinance No. 15-11-12-2024, entitled: "AN ORDINANCE MANDATING BUSINESS ESTABLISHMENTS OPERATING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL TO INSTALL A CLOSED-CIRCUIT TELEVISION (CCTV) SYSTEM AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF".

WHEREAS, there is a need to install a Closed-Circuit Television (CCTV) System in all business establishments within the territorial jurisdiction of the Municipality of Boston, Davao Oriental, to support the maintenance of peace and order and public safety;

WHEREAS, Municipal Ordinance No. 15-12-12-2024, entitled: "AN ORDINANCE PROHIBITING THE USE, MANUFACTURE, SALE, OR DISTRIBUTION OF PNP UNIFORMS, INSIGNIAS, AND OTHER ACCOUTREMENTS WITHOUT A PHILIPPINE NATIONAL POLICE (PNP) CERTIFICATE OF CONFORMITY AND/OR A CERTIFICATE OF DISTRIBUTORSHIP AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF";

WHEREAS, the said ordinance shall be applied to all manufacturers/business establishments, distributors and persons or group engaged in business and any activities in their respective localities which are engaging in using the PNP uniforms, insignias and accoutrements;


